The use of social deixis is not always used in everyday life even in the film too much to use the social use of deixis in its dialogue, for example, a film written by David Sedler is the film *The King's Speech* that are set on the kingdom.

In this research, the researcher is interested to analyze about social deixis in a movie called *The King's Speech*, because researchers think after watching the film

researchers found a lot of data containing social deixis. Therefore the author tries to research about the use of social deixis in the movie *The King's Speech*.

Details of pragmatic elements in a work of fiction can be found by analyzing the work through pragmatics. This may include certain factors as well as the language action in the work or even with social deixis as is done in this study.

Pragmatics is a study of languages from a functional perspective, meaning pragmatics attempts to explain aspects of linguistic structure with influences of phenomena and non-linguistic phenomena (Levinson, 1983:7).

Pragmatics studies the factors that govern our choice of language in social interaction and the effect of our choice on others. In theory, we can say anything we like. In practice, we follow a large number of social rules (most of them unconsciously) that constrain the way we speak. Pragmatics examines the factors that drive the choice of language in social interaction and the influence of that choice on the said partner. In theory, we can say things as we please. Deixis is a word, and will be deixis when it varies depending on who becomes BADDUNG the speaker and depends on the time and place in the word said, for example, my word, here, now (Purwo, 1984:1). Suggests that deixis is derived from the Greek word meaning "to point" or "to show" it has become a technical term in grammatical theory, to deal with the characteristics of "determination" of language related to the nature and place of speech (Lyons, 1995:270).

"Social deixis concerns the encoding of social distinctions that are relative to participant-roles, particularly aspects of the social relationship holding between speaker and addressee (s) or speaker and some referent" (Levinson, 1983:63).

Particularly the movie the king's speech has a major contribution to this research, The film is lifted from the true story of King George VI, the king of England in 1936 until the end of his life, So because of this, social deixis is a phenomenon that researchers are interested in analyzing the use of social deixis in the film The King's Speech.

The King's Speech (2010) is a film directed by Tom Hooper and scriptwriter David Seidler. The film is lifted from the true story of King George VI, king of England in 1936 until the end of his life, this film has an unusual theme in photographing the life of a king. Unlike most films about the world of the kingdom, which usually focuses on courage, heroic, romance, and even ruthlessness, this film is about simple and human, and perhaps even strange because it is not a common thing for a king, stuttering. Stuttering, or speech impediment, to a commoner or even a comedian would be a funny thing, but for a king, let alone a king of an emporium as big as England, stuttering is a disaster. Especially if the stuttering condition that the king, who ruled during the war, was required to broadcast state radio and announced the declaration of war. Precisely from this small theme, by involving the king's mental condition and his attempt to overcome his stuttering, the film becomes interesting.

From the above synopsis, we can see that in this film, has a very strong social element. So we will find many formal and informal languages, which are social deixis.

Meanwhile, this study uses several previous studies as a reference. The first one was conducted by Sunjani (2013) "An Analysis of Deixis Used In "The King's Speech" Film's Dialogue" in his research the author uses Levinson's theory in researching his object and his research conclusions show that the often-used dialogue in the film is dominated by personal deixis and social deixis.

The second is Ratna thesis (2014), whose study focuses on "A Deixis Analysis of Song Lyrics on Taylor Swift" Red "Album". In his research, the researchers use the theory of approach from Yule and Levinson in analyzing the object. The researchers concluded that the lyrics in the album were dominated by the deixis person.

The third is a thesis by Fauziah (2015), whose studies focus on "An Analysis of Deixis in" A Thousand Words "Movie Script by Steve Koren". In the research, the researchers used the theory of approaches from Yule and Levinson in analyzing the object. In a movie script because the story is appropriate for everyday life. In his research, the authors conclude that the use of deixis in the dialogue.

And the last was a thesis by Hariyati (2016) entitled "Deixis in Cinderella Film: Pragmatic Analysis" In the research, the researchers used the theory of approaches from Levinson, with the conclusion of her research is about the use of forms used in the dialogue between characters.

From the previous studies above, the researcher tries to conduct similar research with different objects especially the type and function in social deixis, as a result, the writer choose this topic which is entitled "Social Deixis in "The King's Speech" Movie Script'
