(Adib Sofia, 2009: 19)

A Thousand Splendid Suns is the second work of Khled Hosseini. It tells about two women which is experience sad story in Afghanistan. Two woman's characters couldn't decision their life, because everything in man hand. Because of that woman is struggling to get their independent status.
