CHAPTER I

INTRODUCTION

This chapter deals with seven components such as background. In the background of research researcher explain about movie, movie script, the object of this reasearch, plot, convention and invention. in the statement of problem explain about searching and analyzing convention and invention. Then in this chapter contains research objective, research significance, conceptual framework, research problems and the result of previous studies.

1.1 Background

Movie is a production that is multi-dimensional and complex. The presence of the movie in the middle of the life is more important and on a par with other media. The existence of the movie has been created as one of the media of mass communication really preferred even now. Movie is a part of popular literature. According to Adi (2016, p. 19) the type of popular literature consists of various kinds, which are in the form of novels or movies. One of that supports to making a movie is movie script.

Movie script contains stories and dialogues, scene descriptions, and character movements that will later become a movie. The movie script is used as one of the literary works. Literary work is a medium used by authors in conveying ideas and as a medium of literary works used as a link to the thoughts of the author that is conveyed to the reader. Literary work has the connection between readers and authors, literary works have a different role, in addition to playing a role in the process of transferring information from author to reader, literature also acts as a text created by the author as a text that is perceived by the reader (Sugihastuti, 2005, p. 81). The movie is one part of literary work that has two building elements, namely the delivery element and the narrative element in the form of a movie script (Cahyaningrum, 2012, p. 12). Movie script is the most important component in making a movie. The function of a movie script in a movie as a form and reference material in making a movie so that the plot is appropriate and also used as a basic

material in uniting the perception between the producer and all the crew about the movie that will be produced so that new input and opinions can emerge that can make the movie better. The elements in a movie script are arranged neatly, such as the location, character, atmosphere. The ideas that are united in the movie script will be played by the characters.

The movie script is one of the works of popular literature, the role of a movie script as popular literature because movie scripts are part of the movie. According to Ida (2016, p. 19) that popular literature has various kinds, it can be in the form of essays and some are in the form of fiction, which is meant by fictional works of imaginary works that can change novels or can be in the form of movies. Regarding the popular understanding of literature itself that popular literature is a literary work that is considered popular and new and is prepared with consideration to meet popular tastes or markets. According to Ida (2016, p. 20) popular literature can be said to reflect people's lives, it can be said that the daily reality of a society can be the cause of the emergence of popular literature. In this case, popular is a trend in society that existed at that time. The use of language in popular literature uses language that is light and easy to understand. Popular literature consists of several genres including western, science fiction, horror, detective, mystery, adventure, and romance.

Romance is one of the popular genres of literature. Romance usually focuses on stories of happiness or love stories. The discussing romance which is dominated by love stories certainly has a character in it. The characters in romance are male and female figures, a love story that is central to all parts of the story and a satisfying ending. The crucial defining characteristic of romance is not that is a star a female but that its organizing action is the development of a love relationship, usually between a man and a woman. The genre of romance has become one of the genres that are much in demand by women because in the romance genre women is a central figures, but that is not the main point in the romance genre, the main point is the story between lovers who have a relationship.

The Shape of Water movie script written by Guillermo del Toro and Vanessa Taylor 2016 is a movie script that has a romance genre that tells the story of an

orphaned woman who lives unable to speak or mute and communicates using sign. Her name is Elisa, Elisa lives as a janitor at a high-security laboratory. Guillermo del Toro's movie script follows a mute woman named Elisa who works in a government laboratory in Baltimore during the height of the Cold War. As an infant, Elisa was found on the side of a river with her throat slashed, which rendered her speechless and gave her three large scars along the side of her neck. She thus has trouble connecting with people; her only friends are her co-worker, Zelda, who doubles as her sign-language interpreter at the lab, and her neighbor, Giles, an artist. The laboratory was the place where Elisa found her love. The love story is formed similarly with *Beauty and the Beast* because the love story is told not between human and human too anymore but this love is told between ordinary human and amphibian man. *The Shape of Water* movie script in his love story, that their love story was formed into one of fantasy and impossibility when it happened in real life.

In this research, the researcher chooses to analyze the movie script because it has many things that the researcher can take. Reading movie script has a lot of advantages because the writer can learn from any aspect, especially from intrinsic elements. The elements that are used as fiction builders include story facts, story tools, and themes. Story facts are things that will be told in a work of fiction. The facts of the story in fictional works are one of them is plot (Stanton in Sayuti, 1997: 18). Those are called an intrinsic element, A literary work without intrinsic elements cannot stand because these elements are related to each other. One of the intrinsic elements in the movie script is a plot.

The plot will be the focus of this research. As already known, the plot is a convention of the intrinsic elements of making a literary work. Literary works, in this case, the movie script certainly experiences development, especially in the storyline, the plot will change and have new innovations or what is called invention. The most basic of a convention is the classification of the types of literary texts into three namely prose, poetry, and drama. This is determined by the conventions that apply in certain communities and at certain times. Both convention and invention will develop according to time and social conditions. In general, conventional

definitions based on elements of fictional text, such as themes and settings. However, fiction can also be new in the plot, narrative, and other elements in the story. This happens because the works will be inventions. The convention used as an element that is better known and has a value that continues in a continuous manner, then the original elements will emerge new perceptions. While the invention is intended to see the changes in elements that exist in a literary work, in this case, is a plot.

This research will reveal how plot and convention & invention plot romance that can dominate and also at the same time become a supporting element of *The Shape of Water* movie script. The problem of this research is to examine the convention and invention.

1.2 Statement of Problems

The movie script is a literary work that has developed, from intrinsic and extrinsic elements. One of an extrinsic element in a movie script that has developed is a plot. Knowing the developments in literature, namely in the idea of the creation of new things, known as invention, which had previously been seen in literary works based on the convention itself. From all the importance of knowing the development of ideas, new things in literature, in this case, *The Shape of Water* movie script the researcher formulate two formulations of the problems. The questions in the research are:

- 1. How is the convention of romance plot found in *The Shape of Water* movie script?
- 2. How is the invention of romance plot found in *The Shape of Water* movie script?

1.3 Research Objective

In this research, to identify and analyze convention and invention of plot in *The Shape of Water* movie script has the following objectives:

1. To find out the convention romance plot in *The Shape of Water* movie script based on the theory used.

2. To find out the invention in romance plot shown through *The Shape of Water* movie script.

1.4 Research Significance

This research has theoretically and practical significance. The first significance is theoretically, this research can help who to have comprehension about plot, convention, and invention in popular literature, the readers can understand the theories used by researcher and applied to everyday phenomena. In this research there are two types of literature that need to be reviewed as reference and comparison: first, the literature relating to the material object of this research; and second the literature relating to the application of plot theory, convention, and invention. Research on the same topic as this research, especially the research of plots inaccessible movie scripts has not been found. However, research that uses different perspectives relating to movie scripts, convention, invention, and plot analysis is mostly done.

SUNAN GUNUNG DJATI

The researcher was inspired by several previous studies incuding, the first, Konvensi dan Invensi dalam Cerita-cerita Koboi Mutakhir: Kajian Formula Terhadap MovieWestern Periode 1995-2012 by Andriani, Universitas Gadjah

Mada, 2014. This research discusses the review of convention, invention and external factors that underlie the change in formulas in western works using Cawelti (1971) and the characteristics of western works by Cawelti (1999). The conclusions are reversal type of esthetic structure in Western films period 1995- 2012: first, the setting showed more modern space and tend to reduce savage space; second, weapon and transportation icons used by characters were also more modern; third, the hero became more marginal; fourth, the idea of stories became more variety and dynamic; fifth, situation and type of masculinity actions become more brutal. Furthermore, the formula evolution was caused by production politic, social changes, and the taste of society. The differences between this research and the research in the objects analyzed, Andriadi analyzed western films from 1995 to 2012 while the researcher analyzed The Shape of Water movie script. The similarity of this research is convention and invention in a literary work, the theory of conventions and inventions.

The second, Structural Analysis of Plot in Rick Riordan's Percy Jacson and The Olympians: The Lightning Thief by Dani Irawan, English Language and Letter Department Humanities Faculty, Maulana Malik Ibrahim State Islamic University Malang, 2015. This research focus in the analysis is finding the kind of plot in the story. In this research, the researcher uses Greimas structuralism in analyzing plot. the researcher uses literary criticism as his research design, as literary criticism is regarded as the analysis, interpretation and evaluation on the literary works. In finding the answer of those questions above, the research first step is finding the elements of plot. After finding the elements of plot, the researcher makes a plot table in order to put every event from beginning to the end. The next step is dividing the whole story into three events; every event is analyzed using actant by Algirdas Julien Greimas. After those events are analyzed, the researcher adds together those events in complete event. Then, the researcher makes a plot diagram based on that event. Finally, the researcher concluded what are kind of plot and the ending of the novel. The diffeences between this research and the research in the objects analyzed, this research analyzed Rick Riordan's Percy Jacson and The Olympians: The Lightning Thief while the researcher analyzed The Shape of Water movie

script. The similarity of this research is what the study examined is a plot and struturalism methods.

The third, The Analysis of Plot in Stevenson's Treasure Island by Dewa Ayu Putu Dian Ananda Putri, Non Regular Programe Of English Department Faculty Of Arts, Udayana University, 2017. This research is analysis plot as one of the intrinsic elements of literary work. The novel Treasure Island by Robert Louise Stevenson is used as the data source. The data were chosen because the novel contains of interesting plot so that causing a sense of curiosity about the whole story. It makes interesting to analyze the plot of the novel deeply. The analysis is focused on the structure of plot, the elements of plot, and the types of plot in the novel. Library research was used in collecting data. The data were analyzed using descriptive qualitative method. In analyzing plot in the novel Treasure Island the theory proposed by Barnett Sylvan in his book entitled A Short Guide to Write about Literature (1890) is applied as the main theory. William Kenney's theory in his book entitled *How to Analysis Fiction* (1966) and the theory proposed by Wellek and Warren in his book entitled *Theory of Literature* (1948) are used on supporting theories. The diffeences between this research and the research in the objects analyzed, this research analyzed Stevenson's Treasure Island while the researcher analyzed The Shape of Water movie script and the selection of different title, theories and methods. The similarity of this research with researcher is to use the same object about plot. UNAN GUNUNG DIATI

The fourth, *Plot Analysis of Short Story* "Friends Forever" by Aditi Das Bhowmik by Ahmad syah Ridho, Pipit Rahayu and Andri Donal. English Study Program, Faculty of Teacher Training and Education, University of Pasir Pengairan. This research has a purpose to understand structure of "Friends Forever" short story plot. This research uses descriptive qualitative methods that focus on the concept of a study. This study uses structural hermeneutics by Paul Ricoeur. The result of this research is that the short story "Friends Forever" has a plot exposition, rising action, conflix, climax, falling action and resolution. The diffeences between this research and the research in the objects analyzed, this research analyzed

Friends Forever while the researcher analyzed *The Shape of Water* movie script. The similarity of this research with researcher is to use the same object about plot.

The fifth An Analysis of Plot and Characterization in Sparks's by Siti Halimah Tussadiyah, English Department, Faculty of Arts and Letters Pasundan University, 2017. The content this document is written about plot and characterization, because by describing and analyzing plot and characterization the writer could improve understanding of literary work. The writter chooses to analyze plot and characterization in sparks's The Choice. The reason why the writer choose The Choice novel because this novel get the writter special attention. The choice is a romantic novel written by Nicholas Sparks, this story tells about one man who has anything in his life, and one day he found one woman and change his life. This research is done by using qualitative approach this research deal with words consist of text of narative, descriptive, and dialogue. To describe, analyzed and interpret all of observation and data found is this research the writer used several steps in collecting and analyzing the data, there are: reading the novel, finding, uderlining, and writing down the sentences, the writer will do literary review about literature especially about plot and characterization, and display the data. The process of this research would be doing reading depply and literary reviewing about plot and characterization which uses to keep this research stick to the main aims. Write or collect the data consist of narative, descriptive, and dialogue text. Used data reduction for collecting main data after reading and make summarizes and focuses on the important data. And set the result and make a conclusion. After doing this research the writer founds some result. The plot in the novel using progresive plot. And the plot in this story is simple, it not makes the readers think hard to understand this novel. And has different style from the author. Character which has an important role, there are two lead characters in the novel. There are Travis and Gaby. That two lead characters have characteristic that have made by the author. Travis is describe as a handsome person which was born from well familly and he is animal lovers. He really adores his dad and, and he followed his father footsteps as a veterinarian. Travis is stubborn person and ambition. He is passionate on something and very loyal to his friends and family. The second main character is Gaby. This research is the focus of analyzing the plot and place in *The Jungle Book*. Data is obtained from the plot and place in the film. Data is taken from movies and also from the internet. Steps in analyzing data by collecting data, analyzing data and displaying the results of the analysis. In collecting data using the observation method and analyzing using Guerin's formalist criticism theory. The diffeences between this research and the research in the method, objects analyzed, this research analyzed *The Jungle Book* while the researcher analyzed *The Shape of Water* movie script and in the analysis is about characterization. The similarity of this research with researcher is to use the same object about plot.

The seventh, A Comparative Analysis Of Plot In "The Fault in Our Stars" Novel and Movie Versions by Sri Haryati. Universitas Pamulang, 2015. The analysis of this thesis aims to explain descriptively to the plot in Novel The Fault in Our Stars written by John Green published in January 2012 and later adapted to the film by Josh Boon and aired in June 2014. The theory used in this analysis was taken from Klarer (2004: 15) about traditional plots consisting of story recognition, beginning of conflict, and settlement. In addition to the Klarer theory, this study uses Kenney's theory (1983: 420) about the comparison method, according to Kenney, this method does not only find equations but also finds differences from the object under study. This researcher uses novels and film as the main data, literature and references from the internet as the second data, the data is collected by making quotes or notes from novels and films then analyzed descriptively based

on comparative theory. And the results of this study show that there are several similarities and differences between novel plots and film plots. The differences between this research and the research in the method, objects analyzed, this research analyzed *The Fault in Our Stars* movie and novel while the researcher analyzed *The Shape of Water* movie script. The similarity of this research with researcher is to use the same object about plot.

The eighth, *Plot Structures in A Novel Entitled The Suitcase Kid Written by* Jacqueline Wilson:An Analysis with A Narratological Approach by Siti Aisyah Saraswati Rusdi. English Language And Literature Study Program English Education Department Faculty Of Language And Literature Education Indonesia University Of Education, 2016. This present research aims to analyze the plot structures in Jacqueline Wilson's novel entitled *The Suitcase Kid* (1992) by using Narratology. This qualitative research focuses on the plot of the story in order to analyze how the plot of the story is structured in the novel and to construct the meaning that can be made from the structure of the plot. The findings of this research reveal that the plot of the story is structured like a tree. The plot is developed by a major plot which gives ways for five interrelated plots and forms a story with branching plots. The finding indicates that there are two potential meaning which originated by the structure of the plot. Firstly, the story with branching plots elevates the level of suspense to the reader. Secondly, the set of events in the novel indicates that The Suitcase Kid can be considered as a Bildungsroman novel. The differences between this research and the research in the method, objects analyzed, this research analyzed The Suitcase Kid while the researcher analyzed *The Shape of Water* movie script. The similarity of this research with researcher is to use the same object about plot.

The ninth, *Plot and Characters Analysis on Drama "The Ile" by Eugene O'Neill* by Wahyudi. English Letters Department Adab and Humanities Faculty State Islamic University Syarif Hidayatullah Jakarta, 2009. In this research, the writer analyzes about plot and characters in drama *The Ile* by Eugene O'Neil. Moreover, the writer uses method of descriptive qualitative in analyzing the drama. The drama tells about a steam whaling ship Atlantic Queen that sail to Arctic to

find whales to get the oil. However, the ship stuck there for two years because the ice will not break up, and the ship still does not get the whale. At the end of the two years' period his crew has signed up for, he has only a small part of his quota of Ile. In the analysis of plot in drama, the writer uses theory of plot to get the important points in drama. The data connected with some events, expressions and conflicts that happen in the drama then analyzed by the theory of the plot. Plot in drama is conveyed implied. The writer focuses to analyze plot and characters, which occurred in drama and explain it. The result of this thesis is to explain the plot and characters those are found in drama the lie by Eugene O'Neill. Somehow, it must be understood through unveiling of the elements of the plot ancl characters, those we can found in analyzing every part of the plot such as introduction, rising action, climax, falling action, and resolution. The differences between this research and the research in the method, objects analyzed, this research analyzed *The Lie by Eugene O'Neil* while the researcher analyzed *The Shape of Water* movie script. The similarity of this research with researcher is to use the same object about plot.

The tenth, An Analysis of Life Struggle of The Main Character Through Plot In The Novel The Old Man And The Sea By Ernest Hemingway by Maryam. Program Studi Pendidikan Bahasa Inggris Fakultas Keguruan Dan Ilmu Pendidikan Universitas Muhammadiyah Surabaya. 2013. Ernest Miller Hemingway (July 21, 1899 – July 2, 1961) was an American author and journalist. In 1951, Hemingway wrote The Old Man and The Sea, which would become perhaps his most famous book, finally winning him the Pulitzer Prize he had long been denied. This research is focused in analyzing the characterization and the life struggle of the main character through the plot. This study uses the sources from the old man and the sea by Ernest Hemingway and also from several books about Literature such as character and characterization, types of character, plot and also structure of plot. The researcher uses qualitative research by describing the events that occur in the story because this study wants to analyze the life struggle of the main character through the plot. After gets enough the data and the relevant theory, Then this research present the data analysis. And continues with analysis of the life struggle of the main character and the plot of the old man and the sea by ernest hemingway to answer the problem statement. And for the last part of this study presents the result of the analysis and also the conclusion. The differences between this research and the research in the method, objects analyzed, this research analyzed *The Old Man And The Sea* while the researcher analyzed *The Shape of Water* movie script. The similarity of this research with researcher is to use the same object about plot.

The eleventh, Novel Lalita Karya Ayu Utami: Analisis Alur Menurut Robert Stanton by Salsabila Avinandita. Jurusan Sastra Indonesia Fakultas Ilmu Budaya Universitas Gadjah Mada Yogyakarta, 2015. This research is aimed to analyze the Lalita novel by Ayu Utami. The problems in this research are plot, including plot episode, step plot, conflict, susp<mark>ense, ending, and unity. The theoretical purpose is</mark> to analyze plot with Robert Stanton fiction theory for answering this research's problems. The practical purpose are to improve about plot in fiction and to increase appreciation the Lalita's. This research use descriptive analyze method, for describing fact and data in the text then followed by analysis to provide an understanding and explanation of issues contained in the Lalita's plot. Plot episode which is irreguler causing a delay of events. Conflict that happen cause high suspense and open ending so it can not be separated. Step plot which is not order has related from events today and past events that become an answer from an entire story. The results of this research Lalita has a story inside the story. The novel describes that the plot of Lalita's perfectly unity. The differences between this research and the research in the method, objects analyzed, this research analyzed Novel Lalita Karya Ayu Utami while the researcher analyzed The Shape of Water movie script. The similarity of this research with researcher is to use the same object about plot.

The twelfth, Kritik Kepada Kalangan Perempuan Berlagak Pintar dalam Les Femmes Savantes Karya Molière by Nina Evayanti. Fakultas Ilmu Pengetahuan Budaya Program Studi Perancis, 2010. This research regarding Molière's criticism of women acting smart in his work. This study uses an intrinsic and extrinsic approach through analysis of plot, character, and examination. The analysis of the plot, figures, and examination shows that Molière's criticism directed

at smart-looking women was social criticism to the community, especially Francis women, at that time who were more concerned with cognitive education than their housework. They also overreact to their surroundings. This research refers to qualitative methods with intrinsic and extrinsic approaches. In analyzing the flow in the drama Les Femmes Savantes, the method used is the method of analyzing the drama structure of Freytag. The differences between this research and the research in the method, objects analyzed, this research analyzed *Les Femmes Savantes Karya Molière* while the researcher analyzed *The Shape of Water* movie script. The similarity of this research with researcher is to use the same object about plot and Gustav Freytag's theory.

The thirteenth, The Complicated Plot of Melodrama Formula in Gayle Forman's If I Stay by Dian Hadianti. Undergraduate Thesis, English Studies Department, Faculty of Adab and Humanities, State Islamic University Sunan Gunung Djati. Melodrama is one of genre of popular literature which tells the story, play, or film in which the characters show stronger emotions than real people usually do, discusses in this research. The main reason of this research is the character of melodrama story which changes continually over time lead to the formula of melodrama divided into several periods. But there is one character that does not change until now. That is character of plot which is rather complicated, and complex characters. To specify the research, the analysis divided into two statements of problems, namely: 1. How is formula of melodrama constructed in Gayle Forman's If I Stay? 2. How the complicated plot is describe and support melodrama formula in Gayle Forman's If I Stay? This research used structuralism as literary approach. Thus the data will be cited, classified, described, and analyzed systematically in able to answer the question in the statement problems. The method in this research is descriptive qualitative method, the object and the source of the data of this research is the novel low pressure written by Sandra brown, which was published in 2012 and consist of 30 chapters and 500 pages, while the instrument of this research is note taking. The technique of data analysis in this research used Freytag theory that considered as the plot in Sandra Brown's novel "Low Pressure". In this research, the writer found that in the novel "Low Pressure" written by Sandra Brown, the exposition is detective interviewed as many as they could locate, rising action is Bellamy began to find the killer of Susan, the climax is the killer of Susan is Olivia, falling action is bellamy straighten out all the problems. There solution is tragic. There are 15 data which describe about the plot of murder revelation. The writer concludes that murder revelation of plot in the novel "low pressure" can be seen by five elements according to Gustav Freytag theory, they are exposition, rising action, climax,

falling action, and resolution. The implication of this research is to give understanding about plot of murder reveal based on Gustav Freytag theory. Hopefully, it can give contribution to education as an analysis of literary work, especially for students of English and Literature department. The Fifteenth, Conflicts and Plot in Angie Kilbane's Novel A "The Rainbow Troops" by Dzuriyatul Afifah. Sarjana Thesis. English Education Department. Faculty of Tarbiyah and Teacher Training. State Islamic Institute (IAIN) of Tulungagung. 2017. In analyzing the novel the researcher find out the many problems which were dealt by government in economic and education aspect that happened in this day. Conflict make the main character be the main point because from the conflict main character show his/her effort to solve the problem, a wisdom and fervency of main characters are appear. Conflict within a piece may also be central to the author's view of life or the point, he or she is trying to change a bad life. So conflict is the heart of any plot.
