It is a fiction which tells about the futuristic society in Chicago. *Divergent* is about the story of divided society into five categories according to their priority of choices in life called factions, they are "abnegation" for selflessness, "candor" for honesty, "erudite" for knowledge, "amity" for peacefulness or compassion, and "dauntless" for bravery. The system of dividing society into "faction System". The society believes that the "faction system" has purposed to protect people from the disarray of the world.

Generally, society is conducted from many classes. Classes have been conceptualized quite differently in terms of ownership or non-ownership of the means of production, control of various assets within bureaucratic organizations, and possession of marketable workplace skills. Sometimes, classes are defined by occupational prestige scores, arranged in hierarchical fashion; or, more loosely, in terms of generalized social standing in the community at large. Classes have also been described competing cultures, subcultures, or value-systems (Marshall, Swift and Roberts, 1997: 25).

Beside on the description before, the researcher wants to use Coser (1956:23) Theory. This thesis provides an analysis social conflict in the main character in Vorenica Roth's Novel *Divergent*. Coser argues that. "Social conflict is a struggle over values or claims to status, power, and scarce resources, in which the aims of the conflict groups are not only to gain the desired values, but also to neutralize, injure, eliminate rivals. Conflict various individuals and social groups, which may or may not be overtly observable, and which may or may not break out into open dispute or physical violence.

In this human life according to Burhan (1994:24), Conflict includes in intrinsic element. Researcher chooses for the analysis of conflict after reading and understanding the whole story in a novel that will searched". The Researcher found
