CHAPTER 1 INTRODUCTION

1.1 Background

1.5 Definition of key term

1.5.1 Propaganda

Propaganda is the management of collective attitudes by the manipulation of significant symbols. The word attitude is taken to mean a tendency to act according to certain patterns of valuation. The risk that literature might be constrained to intentionality, motives, or outcomes in the world makes this form of democracy difficult to distinguish from propaganda as it is conventionally understood (and, indeed, Sartre admits that when literature fails, it is time to take up arms), the limits on freedom are also inherent in Sartre's own formulation. The propaganda bring people to the manipulation of the text or action to serve an aim. (Guyer, 2013 : 366)

Politic is a system of view within whose framework people perceive and evaluate both their relations to reality and so each other and social problems and conflicts, the system also compromise program of social activity aimed at consolidation or developing the given social relationship. When the term is political struggle it means that the system is has a conflict about ideological issue (Lenin and Gramsci, 1979)

1.6 Mystery Formula

The main principle about mystery formula is how the story can be reveal and how to discover the top secret of the story in the novel. The discovery of the secret in the novel will make much problems in the story with some consequences the consequences will make the story into a fantasy increasingly in demand many readers. Although the problems that in the story are very complex and it still related to each other, there will be a solution that makes the problem over. Problems that are resolved very rationally make the mystery formula conveyed to the readers. Cawelty said that "The search for hidden secret is primarily an intellectual, reasoning activity (1976)" It means that the narrative of the mystery has the clues that show in the story and sometimes the clue was so unclear or it needs to be decipher by some science or any knowledge.

1.6 Methodology of Research

This researcher is uses the qualitative descriptive method. Qualitative method is the research which is did not give a priority to statistic data, but give a priority to comprehend the meaning of the concept which is verifying. (Endraswara, 2004: 5). In addition, according to Creswell

(2003: 17), qualitative method is emerging the open-ended questions, and the data which use in qualitative method are interview data, observation data, document data, and audio visual data text and image analysis. This is meant that, qualitative method is uses the verbal including written. But that method did not use data statistics. Moreover, Ratna in Setiawati (2012:24) said that descriptive method is the way to describing evidence that followed with analysis.
