Representative is one classification in speech act that state what the speaker believes to be case or not. According to Searly (1976) "Representative is the type of utterance that commits the speaker to the truth of the expressed proposition." The researcher analyzes about representative speech act in Donald Trump's inauguration speech. The research questions of this research are what kinds of representative illocutionary act in Donald Trump's inauguration speech and what are the functions of representative speech act in Donald Trump's inauguration speech. This research uses the theory of Yule (1996:54) in classifying kinds of representative speech acts. The theory of Searly (1979) is used to analyzed the function of representative speech acts. The researcher takes the data from Donald Trump's inauguration speech that has been published in January 20, 2017 in the white house. This research uses qualitative research. Dornyei (2007:25) argues "Qualitative research involves data collection procedures that result primarily in open-minded, non-numerical data which are then analyzed primarily by non-statistical method." The researcher analyses the data by some steps: marking, classifying, interpreting, and analyzing. The result of this research shows that there are 37 data kinds of representative speech act: Assertion (16 data), statement of fact (8 data), description (5 data), stating (4 data), and concluding (4 data). Meanwhile, the functions of representative speech act are 13 data: stating (4 data), reporting (2 data), concluding (4 data), suggesting (2 data), and complaining (1 datum). The researcher suggests to next researchers who want to do the same research, it is suggested to broaden the scope of study with a deeper analysis to find new identification of the theory and it is also expected to analyze with different object, such as muslim figure, advertisement, social media, comic and magazine.

Representative merupakan salah satu jenis dari tutur kata yang menyatakan tentang pembicara yakini menjadi kenyataan atau tidak. Menurut Searly (1976) “*Representative* adalah jenis tutur kata sebuah ujaran yang berpegang teguh seorang pembicara terhadap kejujuran dari ungkapan yang disampaikan.” Peneliti membahas tentang tutur kata *representative* pada pidato inagurasi Donald Trump. Pertanyaan penelitian ini meliputi jenis tutur kata *representative* apa yang digunakan pada pidato Donald Trump dan apa fungsi dari tutur kata *representative* pada pidato inagurasi Donald Trump. Penelitian ini menggunakan teori Yule (1996:54) dalam mengklasifikasikan jenis-jenis tutur kata *representative*. peneliti mengambil data pada pidato inagurasi Donald Trump yang diunggah pada tanggal 20 Januari 2017 di gedung putih istana presiden. Penelitian ini menggunakan metode kualitatif. Dornyei (2007:25) menyatakan “Penelitian kualitatif meliputi prosedur pengumpulan data yang hasil utamanya terbuka, bukan berupa angka-angka yang kemudian hasil utamanya tidak menggunakan data statistika.” Peneliti menganalisis data dengan beberapa langkah: menandai, mengklasifikasikan, menginterpretasikan, dan menganalisis. Hasil dari penelitian ini menunjukkan bahwa ada 37 data jenis-jenis tutur kata *representative*: *assertion* (16 data), *statement of fact* (8 data), *description* (5 data), *stating* (4 data), dan *concluding* (4 data). Sementara, fungsi dari tutur kata *representative* berjumlah 13 data: *stating* (4 data), *reporting* (2 data), *concluding* (4 data), *suggesting* (2 data), and *complaining* (1 data). Peneliti menyarankan kepada para peneliti selanjutnya yang ingin melakukan penelitian yang sama agar mencari lebih sumber pengetahuan yang lebih agar mudah menganalisis lebih dalam dan juga diharapkan dapat meneliti dengan objek yang berbeda, seperti tokoh muslim, iklan, sosial media, komik dan majalah.
