The definitions, therefore, usually include additional adjectives such as "aesthetic" or "artistic" to distinguish literary works from texts of everyday use such as telephone books, newspapers, legal documents, and scholarly writings

(Klarer, 1962:10). Etymologically, the Latin word "litteratura" is derived from "littera" (letter), which is the smallest element of alphabetical writing. The word text is related to "textile" and can be translated as "fabric": just as single threads form a fabric, so words and sentences form a meaningful and coherent text. The origins of the two central terms are, therefore, not of great help in defining literature or text. It is more enlightening to look at literature or text as cultural and historical phenomena and to investigate the conditions of their production and reception.

The title was taken based on research object *perfume*: the story of murderer movie. The author include a qualitative study in this research, The readers can find out this research using qualitative literary methode. Beside, the topic is based on what is equally well know in these works. It is psychological thriller formula.

Perfume: The Story of a Murderer is a 147-minute film directed by Tom Tykwer. The film was released on December 27 in the United States. the film is adapted from the Perfume novel by Patrick Suskind this genre psychological

thriller. This film takes place in the 1800s in the ancient city of Paris. By telling the life of Jean-Baptiste Grenouille the genius who has an olfactory ability that is different from other humans. And he is ambitious to collect the fragrance of a new perfume base.

The film begins with the narrative narration of the narrator who narrates the sentence Jean-Baptiste Grenouille, which in the perspective of thriller formulas is usually plot told through narration. Narrated Jean-Baptiste Grenouille who was born in a fish market in France. His mother gave birth to him while cutting fish in the market. He was then left just like that by his mother under the table where his mother was cutting fish. Because it was known by people around that her mother intended to kill her baby, then her mother was hanged for this action. Grenouille grew into a human being with an extraordinary sense of smell. And in the storyline, he always gets help when he is having trouble. Elements which proves that in this film is a psychological thriller because the main character is a psychopath. Baptiste has killed virgins to be made into perfume.

As we know thriller genre films are tense action films. Thriller films focus on anxiety and fear. Usually, the storyline of the thiller prioritizes the story that the hero is a race against time, full of challenging actions, and always gets much-needed help that must thwart the cruel plans of a more powerful villain and more complete weaponry. The goal is to make the audience happy when the story is watched.

As stated by Sarick (2009, p. 72), "although characters may not be in lifeand-death situations, they always face the danger of some kind, certainly from a conspiracy if not a physical antagonist". In general, thrillers tell ordinary people who are trapped in an extraordinary or precarious situation that is not desired as a mystery, acts of terror to murder. Thrillers heavily stimulate the viewer's mood giving them a high level of anticipation, uncertainty, surprise, anxiety, and terror.

The Thriller genre itself is divided into several sections, and among them is a psychological thriller. The psychological thriller is a narrative thriller that emphasizes the unstable or delusional psychological states of its characters. In terms of context and convention, it is a subgenre of the broader ranging thriller narrative structure, with similarities to Gothic and detective fiction in the sense of sometimes having a "dissolving sense of reality". It is often told through the viewpoint of psychologically stressed characters, revealing their distorted mental perceptions and focusing on the complex and often tortured relationships between obsessive and pathological characters.

States that films that have been labeled psychological thrillers usually refer to "narratives with domestic settings where actions are suppressed and where sensations are given instead through psychological investigations of the main characters. The hallmark of a psychological thriller is that it emphasizes the character's mental state: perception, thoughts, distortions, and general struggles to understand reality.

Psychological thrillers focus on stories, character development, choices, and moral conflict; fear and anxiety encourage psychological tension in unexpected ways. Psychological thrillers are full of tension by exploiting the uncertainty of character motives, honesty, and how they see the world.

However, according to James N. Frey "psychological thriller as a force, not a subgenre. according to him good thrillers focus on their antagonistic psychology and build tension slowly through ambiguity". Creators and / or film distributors or publishers who try to distance themselves from the negative connotations of horror often categorize their work as psychological thrillers. The same situation can occur when critics call a work a psychological thriller to increase the literary value it feels.

What distinguishes psychological thiller from thiller is a stressful psychological thriller, full of mystery, and often infrequently full of bloodshed. In

this film genre, there is the main role that plays a psychological element to build the thiller atmosphere itself.
