1.1. Background of Problem

According to (Danesi, 2010) have three main categories. There are feature films, animated films, and documentation. A feature film is a work of fiction that structure is always in the form of a narrative. Animated film is a technique of using film to createthe illusion of motion from a series of images of two or three-dimensional objects. Documentary films are non-fiction films that describe real-life situations that occur insociety and each individual in it describes his feelings and experiences in real-life situations that occur in society and each individual in it describes his feelings and experiences in situations as they are, without preparation, and directly on camera or interviewer.

Films adopt genres from print as well as from the pre-existing entertainment domain. Which includes including comedy, Western, horror, romance, melodrama and also war stories. One day, the researcher found a horror movie 28 Days Later (Juragan, 2002) and significant analyze this film because they got several awards such as Best Horror Film (2004), Best Horror Movie of the Year (2003) Best Breakthrough Performance (2004), Best British Film (2003) and Best Director (2003).

The intrinsic element is very important in a literary work because before doing a research further about literary work, the first thing we must know is about the intrinsic element. There is seven elements in the film: The theme is the whole story in which thetheme is the main idea that is the basis or main point of the film, the plot is a storylinearranged in such a way from the stages of events to form a series of stories, characters are individuals who play a role, they are involved in a story or conflict in a film, dialogue is a series of conversations in a story. Dialogue techniques are very important to a story.

The characters of each character are greatly strengthened by the spoken dialogue and the style or facial expression, conflict is a problem that occurs in a film. This conflict is experienced by the main character, assisted by supporting figures, setting is the place where every event that takes place in the story line occurs. Not onlythat, the setting includes equipment, time, clothes, culture, as well as those related to the lives of the characters in the story and mandates are moral messages that the author wants to convey to the audience.

The film object 28 Days Later by Danny Boyle is a genre of horror-thriller that wasproduced in British on 2002. This film is written by Alex Garland and directed by Danny Boyle and also staring by Cillian Murphy, Naomy Harris, Christopher Eccleston, Megan Burns, and Brendan Gleeson. The film is about a very dangerous virus that spreading quickly and showed how four survivors to protect themselves from the zombies and have recourse to stay alive. This story happens when a group actives of animal liberation frees the chimpanzees from trial but in fact, those chimpanzees was infected by a virus in the laboratory and causes the virus spreads quickly to people.

In terms of psychoanalysis, a work of art is a manifestation of conflicts that the author unconsciously experiences regarding his childhood experiences or from a work he has read. Interest in a work arises from the fact that in the process of writing a work there is a kind of self-reflection, therefore the passion that is generated causes a person to be able to recognize himself more deeply (Ramadhani D. A., 2018). Because the author experienced that feels from his childhood or some work he has read he will writes a work that the characterization of characters will the same with what he experienced.

Chaotic situation in this film causing the characters have inner conflict. When the characters found someone infected by the virus, they should kill everyone quickly but in the other side the characters doesn't want to kill especially if the infected is their family. When facing this situation the characters would feel a very confusing inner conflict. This is theory psychoanalysis of Sigmund Freud. He developed the concept ofmind structure by developing the "mind apparatus", what is known as Freud's personality structure and becomes its most important constructs, namely id, ego and superego.

The id is the basic structure of personality, entirely unconscious and operating according to the pleasure principle, and the aim of which is to satisfy desires immediately and the ego develops from the id, the personality structure that controls consciousness and makes any decisions about human's behavior. The superego develops from the ego when humans understand the good and bad values and morals. These three things are showed in the film 28 Days Later.

After watching this film, I found some interesting things. There is the plot of the film which is very clear and easy to understand and the second is how the psychological condition of the characters in this film. The reason why this film is important to discuss is because:

- a) An environment will affect human psychology,
- b) Difficult circumstances will change human character, whether good becomes bad or bad becomes good,
- c) The importance of controlling logic and feelings.

This film is studied structurally with the orientation of Ubersfeld's several theories
