**Abstract**

Digitalization of the Koran is a process of changing the vehicle from the beginning of the Koran being limited to written printed form to digital, for example, the Koran (tafsir & per word) by Greentech Apps Foundation and al-Quran interpretation and word by word by Muslim Media. Not many people know information about the background of the formation and differences related to the features of the two applications. The purpose of this research is to find out the background of the formation, features, advantages and disadvantages, and to compare the features of the two applications. The method used in this article is descriptive-analytical. The software that will be examined in this research is the application of the Koran (tafsir & per word) by Greentech Apps Foundation and Al-Quran Muslim Media.
