"Character are the persons represented in a dramatic or narrative work, who are interpreted by the reader as being endowed with particular moral, intellectual, and emotional qualities by inferences from what the persons say and their distinctive ways of saying it—the dialogue—and from what they do—the action."

In Frankenstein novel, there is a character called Victor Frankenstein who has a distorted character. Victor Frankenstein is very curious about the secret life, he is always happy to learn the facts that exist in this universe. First he is interested in the lightning, and electricity and so forth. He grows into a man who is good at. But when he grows up, he becomes an antisocial, ambitious, and he success in creating human beings by combining science and magic. But he was surprised when the creature

creations into an ugly demon and a threat on his life. He was a desperate, full of anxiety, restless life, and apart from the social environment. The character of Victor Frankenstein is in line with the theory of Karen Horney regarding irregularities called Character disorder character. Where, the elements of character disorder include characters such irregularities hopelesness, blame, alienation and anxiety.

In the process of creating a literary work, Minderop (2010:53) state that the author not only express what is in their soul into a work of literature, but necessary educational skills and accuracy in analyzing and incorporate other knowledge, such as psychology, philosophy, anthropology, sociology, and others.

Among all the knowledge, psychology has a dominant role in the formation of literary works. In this modern era of literary works such as novels, plays and poems contain many elements as the psychological manifestations: psychiatric author, the fictional character in the narrative and the reader. The fictional character is a wide range of character and behavior associated with psychiatric and psychological experiences or conflicts experienced by humans in real life.

Frankenstein is one of novel representations concerning the problematic of social, political, and cultural contexts occurred in certain communities. The author of Frankenstein Marry Shelley, explain how revealed the occurrence of these social facts in her novel and explain the Gothic Romance's influences toward the changes of civilization.

In *Frankenstein*, Victor Frankenstein is one of the central figures (main character) in the narrative as a man who has excessive ambition; he creates a living creature that resembles a giant figure of a man, but a giant tangible reality. At first, he created the creature with a noble cause to combat infectious diseases that can reduce mortality. However, once he realized that the creature he created turned ugly and imperfect, he ignored it, which eventually became his imaginary creature a dangerous figure in his life.

In this research, the researchers focus on character disorder of Victor

Frankenstein character that showed in Victor's character. The reasons for this being interesting because Victor displayed not only ambitious character but also the one who has social problem. Separated whether in relation to nature, to other people, to wealth and the means of production in a society, or else to society as a whole. He left everything to his research, including family, friends, and social environments. He became an anti-social man he does not allow anyone to see him. His life only with science and research.

Frankenstein novel explored the problem of social and ambitious man who makes his own self antisocial personality. As in Isti Kumalasari thesis (2012) of UIN Malang, she analyzes The Female Voices in Mary Shelley's Frankenstein: The Modern Prometheus. The thesis focuses on the gender motive of the novel whether it is masculine or feminine by reexamining the novel's bias of gender through the aspects of the absence of the women figures in the entire text which actually

Influenced by the dominant culture of the era within which the novel was written. Then, Tri Damaryanti (2003) of Bina Nusantara University, she analyzes *The Loss Of Humanity By An Excessive Scientific Exploration In Marry Shelley's*Frankenstein. The thesis focuses on analyzing one case that stands out in the novel is that the application of science excessive can lead to the loss of humanity in a person. Victor Frankenstein, the main character in this novel, has experienced its own because of excessive ambition. And the last, Bima Pranachitra (2010) University of Sumatra Utara, Medan. He analyzes Representation of Byronic Hero in Marry Shelley's Frankenstein. The thesis focus on describe the characterizations Byronic Hero, find representation issues in the context of social, political, cultural community in Mary Shelley's novel Frankenstein, explains how social facts that occurred in the lives of the people expressed in the image of Mary Shelley in the novel story.

For these reasons, the writer focuses on the study of the issues character disorder of Victor Frankenstein character that is shown as an antisocial personality such as he was a desperate, full of anxiety, restless life, and apart from the social environment.
